Our Purpose

The North Highlands Citizens' Association is a community organization that plays a vital role in local governance and community engagement, consisting of residents who come together to discuss, advocate for, and address issues affecting our neighborhood.

This is NHCA's 2025 Version 1.1 Neighborhood Plan. Creating the plan was a journey of discovery for everyone involved. Along the way, neighborhood volunteers acted together to address immediate needs and built stronger relationships.

This plan is a snapshot of NHCA in the Spring of 2025. It is the best information gathered so far about what the neighbors think, feel and want for their community. Once approved by the Arlington Neighborhoods Program and the County Board, this Plan will be a vehicle to take further action to strengthen the sense of community, identity and visibility of one of the most beautiful and least known neighborhoods in Arlington County.

NHCA Plan Goals

NHCA Community Dialogues provided neighbors an opportunity to share what they value about their neighborhood, their concerns and improvements that they would like to see. Beginning with the first Community Dialogue in October 2024, strong themes and goals have emerged. These main goals are:

- Pedestrian safety
 - Children walking to bus stop
 - Commuters walking to and from the Metro (especially at night)
 - General pedestrian safety at intersections

- Preservation of green spaces
- Expansion of green spaces
- Undergrounding of electrical wires
- Stormwater Management
- Friendly
 - o Ensuring that the neighborhood is friendly and open to all
- Smart development

Discussions raised concerns about the development occurring and planned both within NHCA and in adjacent neighborhoods. This development, spurred by the county's Langston Boulevard Area Plan, brings opportunities but also challenges for improving the quality of life in the neighborhood. NHCA neighbors want to be informed early and involved in the decisions to achieve smart development.

On May 28, 2025, NHCA reviewed and discussed this Neighborhood Plan Version 1.0 Plan at its community meeting and agreed to submit it to the Arlington Neighborhood Program (ANP). NHCA will use this plan going forward as the foundation for further community engagement and discussion about future needs and priorities for the people who live, work and play in NHCA.

Where We Are

The North Highlands Citizens Association covers the neighborhood running from N. Oak St. in the East to I-66 in the West, and it is bounded by George Washington Parkway in the North and Langston Boulevard South.

NHCA's proximity to the Potomac River is one of its beautiful features, enjoyed by neighbors and nature lovers from throughout Arlington County. The Palisades Trail meanders through Fort Bennett Park, offering spectacular views across the river to the spires of Georgetown, glimpses of ephemerals in the spring, and bright splashes of foliage in the fall.





The Dawson Terrace Community Center and Park are the site of NHCA community meetings and social events. The site offers easy access to the Palisades Park Trail. Over the years, public and private efforts, in parks and private gardens, have preserved and improved the beautiful green spaces of NHCA.

Fort Bennett Park provides several recreational opportunities for the public to take part in, mostly based around the handful of nature trails that make up the



The Custis Trail enters NHCA from the east at Colonial Run. It is the main pedestrian and cycling route for commuting and recreation. It extends through the length of NHCA past the Lyon Village Shopping Center in the west. Langston Boulevard both borders and connects NHCA. In the map below, the green line running from left to right is the Custis Trail. Capital Bikeshare stations are shown with the Capital Bikeshare logo.



Most of North Highlands is within walking distance of the Rosslyn and Courthouse Metro stations. As of June 2025, Metro bus route 3Y no longer exists, while ART bus #55 continues to serve the neighborhood along Langston Boulevard

Everyone who lives in NHCA enters and exits their neighborhood from Langston Boulevard. Therefore, the effects of the Langston Boulevard Area Plan and new development matter to NHCA residents in terms of safety, walkability, livability and environmental concerns. NHCA wants to increase green space and improve safety—for individuals, for any mode of transportation, and for any time of the day or night.

In 2019 the boundaries of North Highlands were

expanded by about one-sixth, incorporating new areas and residents. This enlargement presents both opportunities and challenges—such as the need to foster a shared neighborhood identity among residents, many of whom do not realize they are part of "North Highlands."

The Lyon Village Shopping Center, which was part of this expansion of North Highlands, is a retail hub and important resource. Stores such as CVS Pharmacy, High-Hat Cleaners, BGR, the Italian Store, Starbucks, and the Bike Store all serve residents of North Highlands and other nearby neighborhoods. Cold Stone Creamery and Corcoran McEnearney real estate have moved into the shopping center since 2024. A Sprouts Farmers Market grocery is slated to open in 2026. Since October 2024, businesses at the Lyon Village Shopping center, along with Mom's Organic Market, MuMu's, Burger7 and the 7-Eleven on Langston Boulevard have supported NHCA's outreach efforts to engage neighbors


A safety improvement project has recently been completed (Spring 2025) at the crosswalk from



Cardinal House to the Lyon Village Shopping Center. Pedestrians can activate a flashing light that signals cars to stop for them as they cross Spout Run Parkway to the Lyon Village Shopping Center.


NHCA is a member of the Langston Boulevard Alliance (LBA). NHCA works with LBA, other civic associations, and the County to address the opportunities and challenges presented by Langston Boulevard today and in the future.

Who We Are



As of 2025, NHCA is home to over 3,300 people living in single-family homes, townhomes, condominiums and apartments. Over 70% of NHCA neighbors are renters, many living in high-rises west of N. Uhle Street, including the Park Adams Apartments, the Potomac Towers and Verde Point and large low-rise apartment complexes such as Fort Strong in the west and Park Georgetown in the east. Many of the low-rise apartment rental options are comparatively affordable for Arlington.

Throughout NHCA there are condominiums such as The Residences at Lyon Hill and Cardinal House, many townhome communities such as Palisades Park and Hillcrest and single-family homes, some dating from the 1900s and others built as recently as 2025. NHCA's housing options hold value by making it possible for residents with a range of income to enjoy living in the neighborhood, yet the variety of housing also creates challenges in terms of neighborhood cohesiveness and engagement in civic affairs.



NHCA is a neighborhood of people young and old, and home to individuals and families of all different income levels as shown in the Arlington Neighborhoods Program's Equity Emphasis map below. The Census tract 101501 in NHCA, is categorized as a Low Median Income area.

North Highlands Neighborhood History

The North Highlands neighborhood has evolved over time.

North Highlands' history includes that of native peoples who likely hunted and fished along the banks of the Potomac. Though there is conflicting information about which tribes may have been part of North Highlands history, the following is one summary:

The Virginia Room at the Arlington library had maps and articles from the 1950s and earlier that indicated the location of the Namoraughquend village near Roosevelt Island and mentioned the Necostins lived on both sides of the river as a means of controlling access to the waterway and to defend their settlements (and those settlements often moved).

In October 1989, the Arlington Historical Society led a "tour of North Highlands," visiting fifteen sites of historical interest. The manuscript for the tour prepared by Bruce Gregory McCoy, Dorothy E. Abbott and Bettie Keiger is available on the NHCA website. One of the sites (#11) was the location of a 1988 archeological dig that found evidence of a Native American campsite from the Early Woodland period.

The Dawson Terrace Community Center incorporates the oldest stone structure in Arlington, the Dawson-Bailey House. It is the only building still standing that was within Arlington's many Civil War fortifications. Fort Bennett was constructed on a portion of the Dawson-Bailey Estate (Rio Vista). Nearby is the Dawson-Bailey Spring House, which has been



preserved and connects NHCA's present to its past. Some of these signs that share the story of North Highlands have recently been removed. It is important to the neighborhood that they be restored. They include: The Dawson-Bailey Spring Site, the Bay-Eva Castle Site, and the Tulip Poplar along the Fort Bennet Park Palisades Trail.

Many defensive fortifications were built to protect Washington DC during the Civil War. Markers for these Civil War sites can be found throughout North Highlands today.

A rendering of what Dawson Terrace might have looked like in 1784. The "old stone house" was the site of a Union field hospital during the Civil War.

After the Civil War, many formerly enslaved people lived and worked in the area. As part of the Arlington County "Stumbling Stones" project NHCA intends to work with the Arlington Historical Society to document and preserve in collective memory "the names and life details of the enslaved people" who are part of the history of NHCA.


Safe: Streets, Sidewalks, Lights

Safety is a priority for the neighborhood. From survey responses and in-person meetings, residents cited inadequate lighting, missing sidewalks, dangerous intersections, poor signage, lack of signage, and speeding bikers among their concerns. One specific concern is bikers who fail to stop per posted stop signs and do not give advance warning to pedestrians.

Other priorities include safer pedestrian and intersection crossings and better connectivity to Langston Boulevard and the Custis Trail. NHCA has already advocated for improvements at the dangerous intersections along Langston Boulevard where numerous pedestrian, cyclist and automotive accidents occur.

At NHCA's November 2024 Community Dialogue, the concerns about safety were explored with two of Arlington's community police officers. The interest in improving safety is a key goal of the NHCA plan and a prime motivation for people's support of the plan. It is also likely to emerge in any discussions connected to development related to the county's Langston Boulevard Plan.

Sidewalks are also a common concern because of missing sections, uneven surfaces, and Submission 1 2025-08-03 Page 11 of 39



utility poles and other impediments to safe walking.


Neighbors have raised concerns about street lighting at every community gathering, and it is a high priority for those who live or travel through blocks with inadequate lighting. These concerns include inadequate street lighting creating dark and dangerous blocks, misplaced light poles that block sidewalks, and dangerous and unsightly overhead power lines.

These county street light maps for NHCA show the Eastern and Western portions of NHCA split by Interstate 66.

The East map makes clear that 21st Road N. between N. Scott Street and N. Taft Street is a particularly dark area at night. This block is the path to both Dawson Terrace (where NHCA meetings are held) and the First Church of the Nazarene, which has occasionally hosted NHCA meetings for decades and as recently as 2025. The experience of walking through the dark to NHCA meetings highlighted the need for additional streetlights in certain areas, especially while other areas such as 22nd Street N. between N. Oak and N. Queen are well lit.

In May 2025 NHCA completed an initial inventory of the current condition of streets, streetlights, sidewalks, greenspace and parks. This inventory (Appendix D) also included information related to each of the NHCA plan goals: Safe, Green, Friendly and Smart Development.

The inventory can help to inform future community priorities that may identify projects appropriate for funding by the Arlington Neighborhoods Program, Vision Zero, Complete Streets and/or the Missing Link programs.

Below are examples of safety improvements identified in the inventory process. The full inventory can be seen in <u>Appendix D: Inventory</u>

Green: Parks and Forests



Preserving and expanding the tree canopy in the forests, parks and private property within the neighborhood is important to the community. NHCA applauds the county's Langston Boulevard Area Plan call for 35% tree canopy coverage in any new development. NHCA cautions against

additional density without the livability and environmental benefits that have been promised.

North Highlands also has some trees of significance, including magnificent tulip poplars in Fort Bennett Park that will need to be preserved.

At the neighborhood's eastern boundary adjacent to the Fort Bennett Forest, Colonial Run streams through county and state parkland and then into the Potomac. This area is a secluded forest sanctuary, with a waterfall and beautiful rock formations, all within sight of the tall towers of Rosslyn.

For more than 20 years, the neighbors of NHCA have been clearing invasives and preserving the natural beauty of Fort Bennett Park and the Palisades Trail.

NHCA is surrounded on two sides by a combination of county and National Park Service land. Over the years, neighbors have coordinated with the staff of both the county and National Park Service to help keep the forests and streams clear of trash and debris.

Due to a combination of public and private efforts, stormwater management projects have been implemented over the years in NHCA. Two stormwater management projects were

implemented by the Palisades Park Owners Association over 30 years ago and are still maintained by the Association. These stormwater projects maintain old tree growth on private land and support the preservation of the green space of Fort Bennett Park. More recently the County implemented a stormwater management project in McCov Park and worked with neighbors to install storm drains to improve safety and walkability.



The photo (left) shows where the county cleared invasive bamboo and then planted trees in parkland situated between a single-family home and townhomes. With care, this small park area will become a flourishing greenspace in the years to come.

Volunteers routinely help to clear invasives and remove detritus from Fort Bennett Park. Tires and other heavier materials were piled up along the path for disposal by county staff.

Such partnership between county staff and neighborhood volunteers has been invaluable. NHCA hopes to strengthen these partnerships and involve additional

neighbors.

Friendly: Community Engagement

Many of the people who participate in NHCA dialogues and meetings do so because they want to connect with their neighbors and build community. During community meetings, neighbors made suggestions about how to engage more people, especially those who were not coming to meetings or were otherwise not receiving information.

This commitment to community-building that reaches more neighbors in NHCA is highlighted in the Community Dialogue Results Section of this plan.

Some of the strategies are already being carried out by volunteers, such as the development of the NHCA website, the use of the Dawson Terrace Community Center as a meeting place and communication hub, and engaging neighbors in McCoy Park on weekends. Other engagement activities, such as the ice cream social and the fall picnic, are designed to be repeated on a yearly basis.

NHCA is grateful for the support from County staff in helping to make the Dawson Terrace Community Center a "friendship hub" for the neighborhood, as well as the McCoy Park and Fort Bennett Park beautiful gathering places.

One improvement that we would like to make is a prominent message board along the Custis Trail and 20th Road North. This would give a highly visible and central location for



neighborhood news that would encourage and sustain community engagement. Being next to the Custis Trail which ties the neighborhood together this will be a valuable addition to the "welcome to North Highlands sign" that we are proposing and the Dawson Community Center Message board that we are already using. We imagine that this message board would be similar to that pictured below at the Custis Trail and Washington Boulevard in the Waycroft-Woodlawn Neighborhood.

Smart Development: Planning and Zoning

NHCA participated in the Langston Boulevard Alliance and county-sponsored design sessions that led to the County Board's adoption of the Langston Boulevard Area Plan in 2023. NHCA is participating in providing review and community reactions to the early development projects. The NHCA Planning and Zoning Committee is very active, indicative of the concern that neighbors have about the development occurring both within NHCA and adjacent to NHCA.

NHCA will remain engaged as the Langston Boulevard Area Plan guides development along Langston Boulevard and will also be engaged when many of the older multi-unit and single-family dwellings that are not within the Langston Boulevard Planning area undergo redevelopment.

At the same time, the General Land Use Plan (GLUP) and county zoning reflect the mixture of housing types that make North Highlands so challenging in terms of balancing the needs for improving the infrastructure, preserving the green environment, enhancing the quality of life, and supporting growth and smart development. Achieving that balance of smart development under the county's Langston Boulevard Area Plan benefits from the engagement of NHCA but also needs county support (funding, mailings, attention, expertise) to ensure robust community engagement. NHCA does not currently have extensive volunteer structure and time, nor the financial resources to reach the residents who live in the neighborhood, especially in multifamily buildings where access is controlled.

When visioning was done in 2015-16 for transforming Langston Boulevard (then Lee Highway), participants in one survey highlighted familiar issues in Area 5 (North Highlands, Spout Run, Lyon Village):

- Not walkable
- Many apartments are dated
- Big parking lots and not enough green space
- I-66 is a barrier.

The Langston Boulevard Area Plan, approved by the Arlington County Board in 2023, may hold some hope for changing that assessment depending on how any new developments adhere to the Plan's recommendations for safety, walkability, tree coverage, transportation improvements and environmental concerns (such as preventing stormwater problems).

Priority One: Establishing Neighborhood Identity and Connection

One of NHCA's four goals is to create a shared sense of community across the entire North Highlands neighborhood. Yet because of expanded civic association boundaries, many residents are unfamiliar with their neighbors, and the "North Highlands" name and concept.

Therefore NHCA's first strategic priority is to strengthen neighborhood identity and foster meaningful connections among residents. Actions under consideration include participating in the Neighborhood Sign Program as available through Arlington County Neighborhoods Program. This strengthening of neighborhood identity will better allow collaboration between residents and the County.

The idea of having neighborhood signs was greeted with enthusiasm at the March 2025 Community Dialogue with Naudy Martinez of the Arlington Neighborhoods Program.

Once the NHCA V.1.1 Plan is approved, a proposal to the Arlington Neighborhoods Program is the creation and installation of neighborhood signs welcoming people to North Highlands.

Neighborhood Sign conceptual design:

- Design Theme: Tree + Hill + River logo motif with modern typography; use NHCA colors (green, blue, orange, black)
- Draft Messaging: "Welcome to North Highlands A Connected Community"
- Suggested locations:
 - Langston Boulevard & N. Oak
 - Langston Boulevard & N. Quinn Street
 - Langston Boulevard & N. Veitch Street
 - Entrance to Fort Bennett Park

The Neighborhood Sign Program will help to create visibility and community connection in North Highlands.

While not a prerequisite to further work, establishing a better neighborhood identity will help the neighborhood to collaborate on issues affecting residents. The most important goal for residents of North Highlands who responded to the survey was on pedestrian and traffic safety. By forming a better community, NCHA can better collaborate with residents in order to listen to their concerns and work on ideas on how to fix problems.

Summary of Progress: 2024/25

In the summer of 2024, after a hiatus during the pandemic, NHCA rejoined the Civic Federation and by October of that year had elected a Board and established a Social Committee and a Planning and Zoning Committee. Key accomplishments include:

- 1. Distributed 1,000 flyers to every accessible home.
- 2. Expanded and updated our email contact list through sign-in sheets, posted flyers in public areas, the use of QR codes, an icecream social and other methods.
- 3. Received approval from the County to use Dawson Terrace Community Center for NHCA committee meetings and Community Dialogues.
- 4. Held Community Dialogues in November 2024 and in January and March 2025.
- 5. Established a Neighborhood Planning Committee in January 2025 and adopted four goals (Safe, Green, Friendly, Smart Development) for the NHCA Plan.
- 6. Began a community survey process in March 2025.
- 7. Partnered with the Langston Boulevard Alliance to develop a mini-grant proposal to strengthen community connection.
- 8. Volunteer developed and supported NHCA website¹ that went live in April 2024.
- 9. Participated in the LBA Community Center Committee and the Arlington County Digital Equity Alliance.
- 10. Hosted Community Service Police Officers and staff from the Arlington Neighborhood Program at Community Dialogues.
- 11. Scheduled a July 13th ice cream social and a September 13th fall festival at Dawson Park Community Center and playing fields.



Appendix B: Survey Results

As of May 25, 2025, NHCA received 64 survey responses. It is useful to keep in mind that many smaller communities exist within the larger neighborhood of NHCA.

For example, while many people said they feel safe walking or biking in the neighborhood, the number one priority for people is improving safety. This is understandable since the condition of the streets and sidewalks can vary dramatically from block to block. Depending on the time of day and year, or the path taken when on the way to work or school, strolling for recreation, walking their dog or biking – an individual's experience of safety will vary considerably.



Suggestions for Improving Safety

More lighting:


- Better lighting in some darker areas
- Smoother path and intersection with sight lines.
- Better sidewalks
- There's not much traffic due to how the neighborhood is laid out, so I don't think any improvements need to be made
- Bikes and cars respecting pedestrian safety rules

- The Custis Trail is dark in some places and narrow which can be a risk factor for accidents.

 Visibility mirrors on blind, hedge-blocked turns, fewer delivery vehicles blocking traffic, drivers off their phones.




Suggestions for Improvement:

- More sidewalks where there are none
- A big problem is the air traffic noise. It really makes me consider moving elsewhere.
- A golf course.

- A number of public spaces and infrastructure are nice to have; they require more timely maintenance and constant upkeep. Numerous public spaces are 'tired' and need attention
- Better traffic control at the corner of Rolfe and 21st Rd N
- Bury poles that are obstructing sidewalks (21 road especially)
- Clean up parts of McCoy Park that border the highway.
- Cutting the bamboo without prior consultation with the neighbors in the area behind N. Scott street presented a big issue for the neighbors. The area has not been replanted and has encouraged unsolicited visitors walking their pets in the watershed area. Over three years later, we have not recovered the tree canopy/shade the bamboo had provided for us and it is a big loss for all of us involved.
- Drainage on Troy Street could be better
- Expand and improve Dawson Terrace so it provides comparable amenities to what residents in other
 parts of the county receive. Increase green space and reduce density. Build wider walking paths to create
 a less intense urban, crowded environment.
- I am not prepared to address air quality, traffic density and noise (from cars and motorcycles and trucks) with redesign improvements.
- I think the needs of the Western and Eastern part of North Highlands differ so can only speak to the eastern part. We need to ensure people in the Western portion contribute to the plan.
- I think there could be a bit more lighting in the area!
- I want more food trucks
- If there's something we can do about noise pollution enforcement /fines for the people drag racing on 66 (southern edge of neighborhood)
- Improved sidewalks; traffic management infrastructure improvements; better connectivity of The civic association area by walking trails in lieu of relying on Langston Boulevard sidewalk system or the Custis trail
- Insect mitigation strategies close to parks and GW Parkway
- Install an outdoor pullup bar or two in northern Arlington. Like the one near Thomas Jefferson High School. I've been wanting that for years! It's a great, free way to encourage exercise, health, and enjoy the outdoors. I imagine installing a couple at a few parks across Arlington wouldn't cost a whole lot. On Old Dominion Drive from Arlington to McLean, make a bike trail or bike lane on the portions for which there are none. I work in McLean, and have to bike in the 1-lane road for a bit of the journey for which there are no trail/sidewalk/bike lane, and it is dangerous because cars which by within inches, they take daring chances around blind corners, and I've also been honked at and yelled at numerous time, and I do feel bad when I inevitably hold up a line of cars because there's no bike lane.
- More and brighter, lights, as well as increased presence to ensure pedestrian safety.
- More food trucks
- More frequent garbage pick-up by the dog park.
- More lighting.
- More park maintenance
- More parks please
- More streetlights along trails
- None, we have enough, it's time to focus on giving to surrounding communities or to a shelter for people unhoused in this area
- Parking restrictions. With RTO more commuters are parking and ditching through neighborhood fast.
- Remove obstructions from sidewalks
- Sidewalks and path are uneven, poorly lighted and have no sightlines.
- smoother streets
- Speed bumps on N Wayne, and 20th st between N Wayne and N Vance being one way
- Stop "domesticating" the Palisades trail and park with lawn grass in open areas and use of leaf blowers and wood chips on the trail.
- Storm drains can't handle large quantities of water.
- The 20th Rd. asphalt driveway has lots of patches looks bad. It needs to be redone.
- The speed cameras light is blinding.
- Underground power lines, add sidewalks and add lighting in some areas
- We may want to get the streets repaved soon.

- We're missing sidewalks. Do people want them? Some intersections are terrible. More underground utilities.


